**ORDER SETTING AND NOTICE OF:
DEADLINE FOR FILING PROOF OF
CLAIM**

TO: ALL CREDITORS AND OTHER PARTIES IN INTEREST:

Upon consideration of the Debtor's request that the Court set a deadline for creditors to assert any claims that they may assert against the Debtor or its estate, the Court finding that a claims bar date will speed the administration of the Debtor's bankruptcy case, and other good cause appearing:

IT IS ORDERED AND NOTICE IS HEREBY GIVEN THAT:

1. **PROOF OF CLAIM BAR DATE:** The Court has set **October 1, 2018, as the deadline for non-governmental creditors to file proof of claims** if they desire to share in any distribution in this bankruptcy case. The deadline for governmental units to file proof of claims, other than for claims resulting from a tax return filed under 11 U.S.C. §1308, is the later of the above noted bar date or 180 days after the order for relief. The deadline for governmental units to file proof of claims resulting from a tax return filed under 11 U.S.C. §1308, is the later of the above noted bar date, 180 days after the order for relief or 60 days after the filing of the

1 tax return.

2 2. **HOW TO PREPARE AND FILE A PROOF OF CLAIM:** Information regarding
3 how to file a proof of claim, and a proof of claim form (Bankruptcy Form B 410), can be found
4 on the Court's website at <http://www.azb.uscourts.gov/proof-claim-form-and-instructions>. To
5 be timely filed, the proof of claim must be **received by the Clerk of the Court**, 230 N. 1st Ave.,
6 Suite 101, Phoenix, Arizona 85003, on or before the deadline set by the Court.

7 3. **CREDITORS NEEDING TO FILE CLAIMS:** The Debtor has filed with
8 the Court its schedules of assets and liabilities ("Schedules"). The Schedules contain lists of
9 creditors, the Debtor's statement as to the type and amount of each their claims, and whether the
10 Debtor believes each claim is disputed, contingent or unliquidated.

11 A. **Unscheduled Creditors:** Any creditor whose claim is not listed in the Schedules
12 **must file a proof of claim** to share in any distribution in this case.

13 B. **Scheduled Creditors listed as disputed, contingent or unliquidated:** Any creditor
14 whose claim is listed in the Schedules as disputed, contingent or unliquidated, **must**
15 **file a proof of claim** or its claim will be disallowed.

16 C. **Other Scheduled Creditors:** Any creditor holding a claim that is listed in the
17 Schedules that is not listed as disputed, contingent or unliquidated, **may, but need**
18 **not, file a proof of claim** to share in any distribution in this case. Failure to file a
19 proof of claim will be deemed the creditor's consent to the Debtor's statement as to
20 the type and amount of the claim.

21 4. **SERVICE OF THIS ORDER:** The Debtor shall (i) serve a copy of this Order **on**
22 **all creditors and interested parties** not later than seven days after entry and (ii) file an affidavit
23 of service within seven days of such service.
